If you have any questions regarding these Rules or Requirements; please call to clarify or confirm; **DO NOT** assume! All official's decisions are final!

Pit Rules:

- All persons must sign the release form and purchase a pit pass to be permitted in the pit area or on the track. All pit passes are \$20.00, regardless of age.
- No persons under 16 years of age are allowed in the pits without parental permission; before, during or after the event.
- No alcoholic beverages or intoxication allowed in the pits before, during, or after the event. Subject to disqualification, forfeit of price, removal from the grounds, and/or arrest.

Requirements to Participate:

- No combine entries allowed through the Pit Gate after 5:30 PM.
- Each driver must fill out an entry blank and register at the desk no later than 6:00 PM
- All drivers must be 16 years of age or older with a valid driver's license, permit, and parental permission.
- Driver and at least one (1) pit crew are expected to attend the pit meeting when called.
- Driver and at least one (1) pit crew are expected to attend the inspection when called.
- All drivers must supply their own combine, only one entry per person per class.
- Combines will be inspected by competition officials. An infraction of the rules must be fixed before the machine will be cleared to compete.
 - After passing inspection the driver will be given a colored stick and this must be mounted near the driver area so it can be broken off after the driver is unable to continue or is disqualified.
- NCCFC reserves the right to approve or reject any and all entries.
- Seatbelt and D.O.T. approved helmets are required to be worn during competition. A fire extinguisher must also be on board the combine.
- **If you are pregnant, have back problems, and/or heart problems; you are NOT permitted to compete.**
- Combines may be decorated, painted, or offer advertising but must be in good taste. No profanity or obscene materials will be allowed.
- Any flagrant violation by driver and pit crew, reckless driving, foul language, or action toward official or fan will result in disqualification and forfeit of prize money.
- Any driver or pit member disobeying the rules will cause his/her combine to be disqualified. Unsportsmanlike conduct will not be tolerated.
- All drivers and pit members must sign a personal injury release.
- All drivers and pit members must follow all safety practices.
- All equipment must be removed from the fairgrounds within 48 hours of completion of the derby.
- NCCFC will not be held responsible for any combines, vehicles, parts, or personal property before, during, after the event, or overnight.
- Transporting of combines to and from must meet Indiana Highway Safety codes. (Tow bars, trailers, safety chains, lights, etc.)

Combine Build Rules:

- Exhaust must exit vertically
- Batteries must be mounted higher than 4' on combine, away from the driver and some sort of covering over them.
- Original fuel tank must be removed and new fuel source placed into the grain tank
- Radiators/coolant systems must have WATER ONLY NO COOLANT!
- Tires filled with air only - no fluid or foam
- Combine must have some sort of head on it
- Platform must have reel, sickle, and snouts removed.
- Corn head must have snouts and row units removed
- Combine ladder, unload auger, chopper, and cab glass must be removed.
- Drivers door must be welded / chained shut
- Safety bars must be added to the driver's door side of the cab for driver's protection.
- Fixed head - Head height 18" to 30"

Event officials' decisions are final. The committee reserves the right to make changes to these rules as deemed necessary.

The event director shall be empowered to permit minor deviations from any of the specifications herein or impose any further restrictions that in his/her opinion do not alter the minimum acceptance requirements. NO EXPRESSED OR IMPLIED WARRANTY OF SAFETY SHALL RESULT FROM SUCH ALTERATION OR SPECIFICATIONS. Any interpretation or deviation of these rules is left to the discretion of the officials and the Noble County Community Fair Board. The Noble County Community Fair Corporation is not responsible for any accidents or injuries.
