## **Noble County Community Fair 2024 Cutest Baby Contest**

### **Rules & Regulations**

- 1) This contest is only open to individuals who are between one (1) and four (4) years of age as of July 13, 2024. One entry per person, duplicate entries may result in disqualification from the contest. Verification of age may be requested.
- 2) Submit one 5x7 or 8x10 photo of your baby or toddler.
- 3) Include (above) Registration form along with photo.
- 4) Submit Entries via mail, postmarked no later than July 1st or drop off at the Fair Office no later than Sunday, July 14, 2024.
- 5) Photo may only include one (1) eligible child or one (1) set of multiples (i.e., twins, triplets).
- 6) The contestant must be appropriately clothed. Entries of children who are not clothed will not be accepted. Bathtub and diaper photos will not be accepted.
- 7) Photos may not depict any child in an unsafe or inappropriate manner.
- 8) If a professional photo is submitted to our contests, the NCCFC will not be held responsible for securing usage rights from the photographer. It is highly recommended that the parent or guardian receive rights to use the photo prior to contest submission.
- 9) The entry may not prominently feature any third-party trademarks, logos, artwork, and must not violate anyone's rights, including but not limited to, copyrights or trademark rights. You must have all rights and permissions to submit and share your entry.

### **Judging**

- 1) Judging begins on Monday, July 14, 2024 at 7:00 AM and ends on Saturday, July 20, 2024 at 10:00 PM.
- 2) Voting is cast in the Merchant's Building Entrance Lobby.
- 3) Coin/Cash votes are tabulated on Saturday, July 20, 2024 at 11:00 PM

### **Prizes**

- 1) Grand Prize, Second Prize, Third Prize

All prizes will be given as represented unless there are fewer than 10 entrants. In this instance, a prorated portion of the prizes will be distributed to the winners.
